23	Nystuen of Lakeside's appointment to the Montana Board of Regents. Chairperson Lund asked each
24	applicant to introduce themselves and asked each candidate five questions: Please tell us about
25	yourself, including any experiences or skill that you would bring to the FVCC Board of Trustees,
26	Why are you interested in serving on the FVCC Board of Trustees, What do you think the role of a
27	FVCC Trustee is, In your opinion, what do you see as the biggest challenges facing the college in the
28	future and Why should we consider you as a strong candidate for this position. Each applicant was
29	interviewed individually. Applicants were then open to any questions the Board might pose. After
30	presentations had been completed, the Clerk of the District passed out ballots for a vote of the Board.
31	The Board voted for their top candidate during the vote, voting for one candidate. After votes were
32	counted by the Clerk of the District (there were four votes cast for Jeremy Presta, one vote cast for
33	Terry Kramer, and one vote cast for Connie Leistiko), with a majority vote, Jeremy Presta was
34	appointed to fill the vacant position. Mr. Presta will be given the Oath of Office at the next regularly
35 36	scheduled Board meeting on Monday, September 28. All the Board members thanked all applicants for their interest and participation and encouraged all applicants to continue their interest in FVCC.
