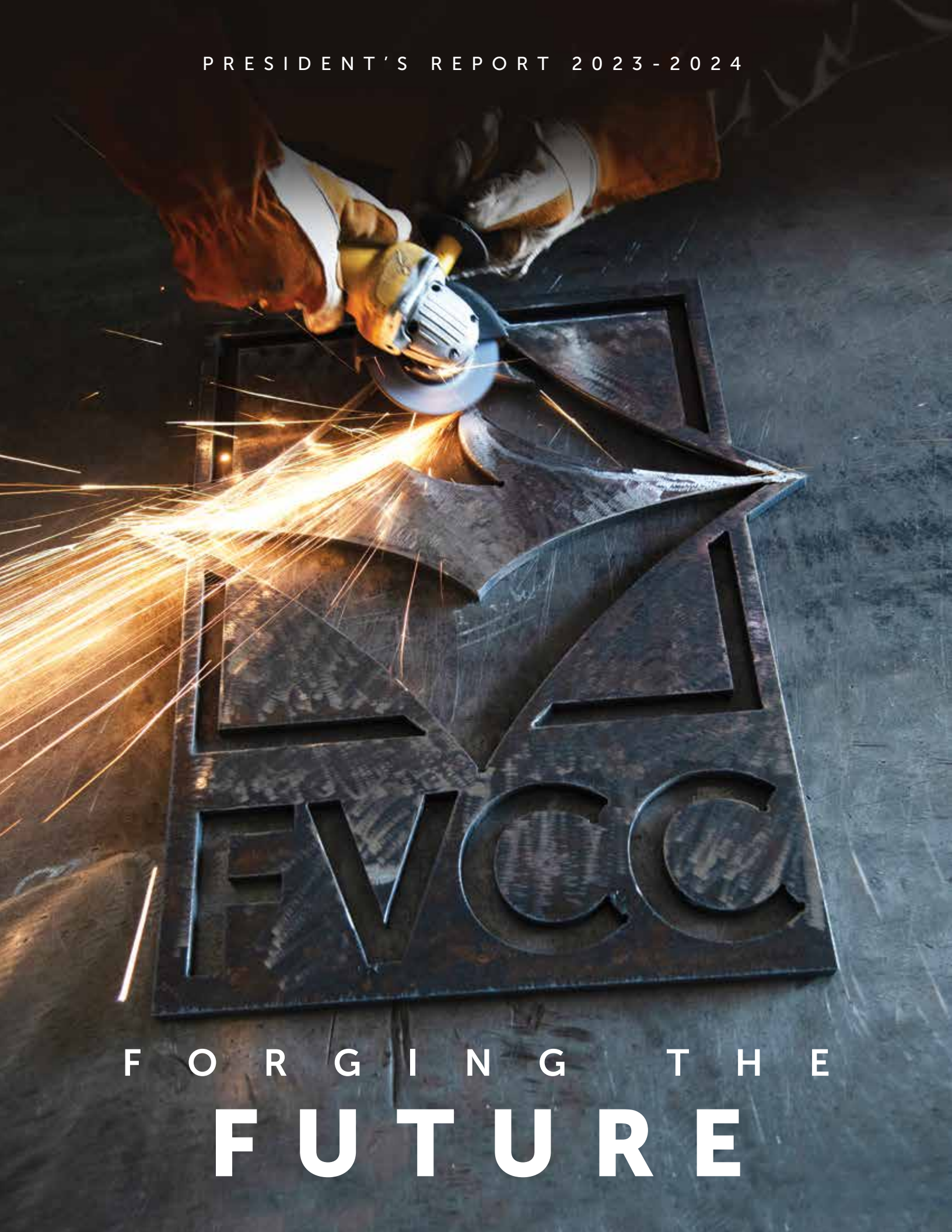

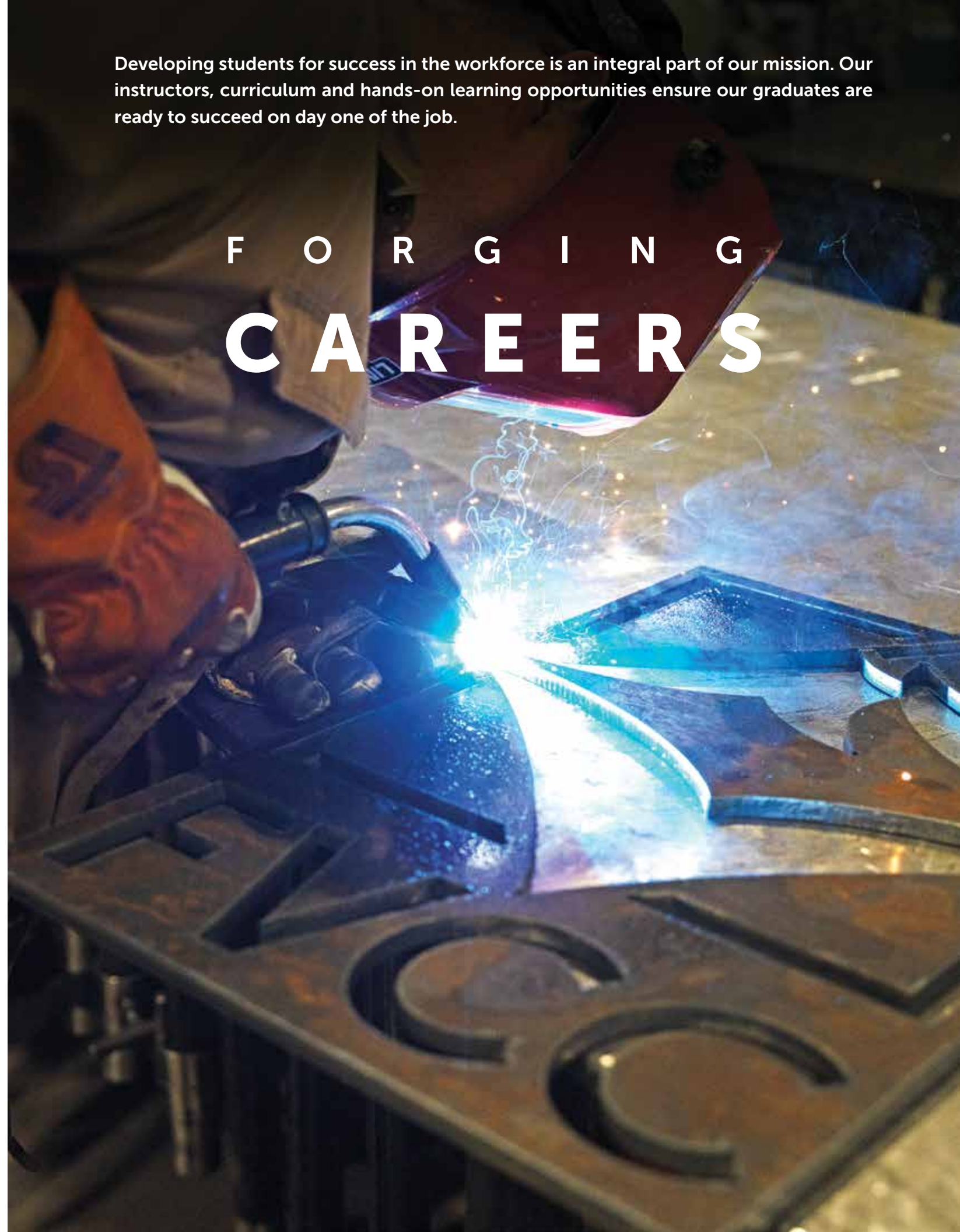

## FAST-TRACK TO SUCCESS

### FVCC's New Plumbing Apprenticeship Course

**"It's a great advantage for the plumber and their employer."**

A number of local plumbing companies expressed interest in creating a program to help their apprentices complete the required coursework and modules more efficiently. FVCC's Workforce Training team took action and launched a Plumbing Apprenticeship course led by retired Montana Chief Plumbing Inspector Dave Micone. Currently, apprentices can work in the field during the day and attend evening classes for valuable training from an industry veteran and to get help troubleshooting real-world problems. The course sets a manageable pace, allowing apprentices to save an entire year on the bookwork portion of their apprenticeship. Upon completing the class and required on-the-job hours, apprentices can take the state exam to earn their journeyman license and receive a substantial pay raise.

Local apprentice Randi Erickson enrolled in the class to stay on top of her apprenticeship bookwork. "This class is really beneficial. I learn a lot of things that help me when I'm working in the field. Dave also teaches us a lot of up-to-date codes that have changed."

As a mom juggling kids and a full-time job, Randi finds the course particularly valuable. "It is difficult when you're going through the bookwork on your own. My kids are in sports, I'm working full time, and then all of a sudden you realize you're falling behind. So it's been great, this class is really important."

As one of the few colleges in the country with a gunsmithing degree program, FVCC provided Aiden with the specialized education he desired right in his hometown. Excelling in high school, Aiden became familiar with the college through the Running Start program during his senior year.

"I was unique in the fact that I had already chosen my major by the time I came to FVCC. All the instructors are so welcoming and value the one-on-one connection to learning, and that's a large reason why I chose to come here after high school."

Already an award-winning shotgun shooter, Aiden is now honing his skills through the firearms technology and industrial machining programs at FVCC. These programs are instrumental in helping him achieve his future goals while allowing him to stay connected to his community. "By staying here and staying local, I was able to continue with the things I already have going on in life while getting my education."

Aiden's educational path is also driven by his strong call to military service. He plans to enlist in the Army marksmanship unit after graduating with both degrees from FVCC. "My goal after FVCC is to enlist. We have a family history of serving in the military, and it turns out I could have a chance to work toward Olympic shotgun shooting after a few years. Not many people know that."

# WACHHOLZ COLLEGE CENTER

A Hub of Community and Student Engagement

After opening in November 2022, the Wachholz College Center has become an important hub for the community and students. In that time, over 40,000 patrons have attended musical performances and speaker series in **McClaren Hall**. The **Wanda Hollensteiner Art Gallery** has hosted five exhibitions in its inaugural year, featuring works from Rembrandt, Kevin Red Starr and FVCC Faculty.

The Wachholz College Center is also the home of FVCC's Music Program. Students attend classes and regularly perform in recitals and ensembles that provide them with invaluable opportunities to showcase their skills. The **Stinson Family Event Center** is the home of intramurals for students. Campus Recreation routinely gets staff in on the fun as well with multiple "Staff vs. Students" competitions in volleyball, basketball, dodgeball

and more. Continuing Education has presented over 70 fitness classes promoting health and wellness for community members.

With a state-of-the-art venue for learning, performing and connecting, the Wachholz College Center demonstrates FVCC's commitment to enriching student experiences and community engagement.





# FVCC FOUNDATION

## The Impact of Investing in Education

The FVCC Foundation plays a crucial role in advancing our mission to support students and faculty. In this academic year, the Foundation awarded over **\$1.7 million in scholarships to more than 670 students**, enabling them to achieve their educational goals.

A wide variety of events held throughout the year raised funds through the generosity of our donors. Proceeds from the Festival of Flavors kick-off event at the O'Shaughnessy Amphitheater and the Grand Wine Tasting at Stinson Family Event Center, as well as strolls of Bibler Home and Gardens and a dozen dinners and events all go toward the support of student scholarships at FVCC.

To foster innovation and enhance learning, nearly \$40,000 was awarded to faculty and staff through Enhancement Grants.

Beneficiaries included:

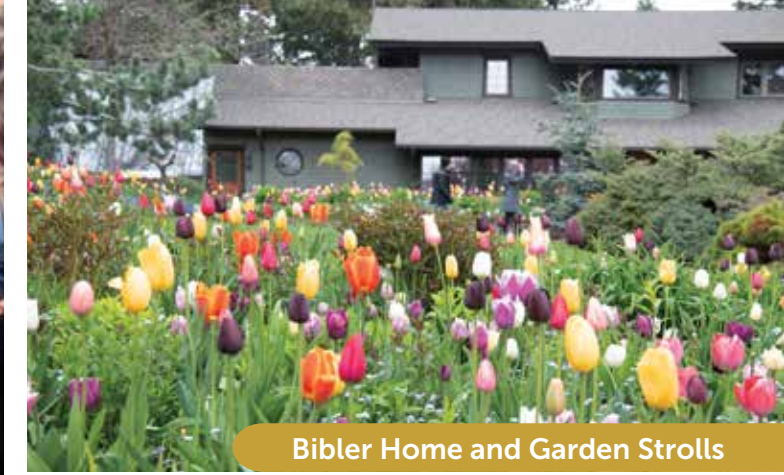
- **Music Department** Middle School Choral Festival, instrument purchases, drumline camp

The FVCC Foundation also raised over **\$75,000** during the six-week **Great Fish Community Challenge**, involving 70+ area nonprofits, with funds allocated to scholarships, academic programs and campus learning facilities.

Through these impactful initiatives, the FVCC Foundation continues to provide essential support and opportunities for our students and faculty, making a profound difference in our community.

Vanessa was inspired to pursue a degree in substance abuse counseling from her close experiences with addiction. She credits an addiction counselor to helping change her life, and now has dedicated her education and career to helping others in the same way.

Vanessa shared her powerful story at several Foundation events in the fall, which led her to a surprising discovery. She says that the opportunity to speak in front of others really allowed her to come out of her shell and be more comfortable speaking in public. As for the future, she’s considering continuing her studies to achieve a bachelor’s and master’s degree with aspirations of opening her own treatment facility one day. “I’m excited to see what comes next and I’m ready to just dig in and learn more and find out ways that I can help.”

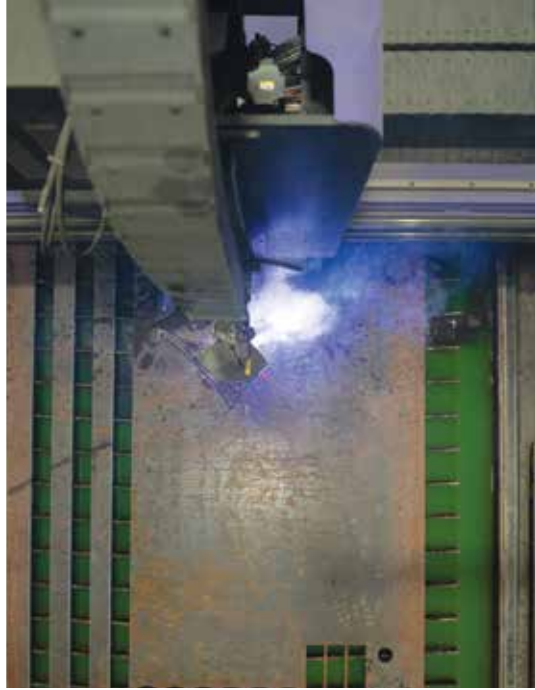
